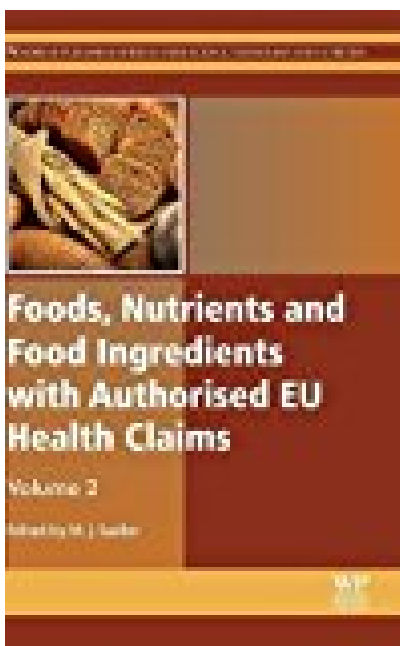

Building on volume 1, this title ensures that the area of EU health claims in food is comprehensively covered. Chapters are devoted to individual food ingredients and substances, covering the range of issues related to health claims. Health-promoting products are an increasing consumer trend in product development and this book provides key information on these advances.
